APPLICATION INSTRUCTIONS

Previous Full-time Members of the Fulton County Sheriff's Office or Reserve Unit

1. Applicant must be in good standing with POST before proceeding with application process.
2. Fill out Returning Employee Application.
3. Fill out the four page Fulton County Government application.
4. Fill out Background Investigation Form.
5. Print out a current copy of your POST record and return with above application.
6. Provide a letter of good standing from current employer.
7. Provide a copy of your Current Georgia Driver's License and a certified copy of your 7 year driver history.
8. Provide a Doctors Affidavit using the attached POST approved form.
9. Provide a copy of your social security card.
10. Provide a copy of your birth certificate.
11. Provide a current copy of your credit report.
12. Provide a copy of your High School Diploma or GED.
13. Pass a polygraph exam.
14. Pass a random drug screen.
15. A review of this information along with previous employment records will be reviewed.

New Applicants

1. Fill out Background Investigation Form.
2. Fill out Background booklet.
3. Provide a letter of good standing from current employer.
4. Provide a copy of your Current Georgia Driver's License and a certified copy of your 7 year driver history.
5. Provide a Doctors Affidavit using the attached POST approved form.
6. Provide results of Compass, or ACT, or SAT, or ASSET Exam - Required for POST certification
7. Provide a copy of your POST record if you are already certified.
8. Provide a copy of your social security card.
9. Provide a copy of your birth certificate.
10. Provide a copy of your United States Naturalization document, if applicable.
11. Provide a copy of United States Military Discharge Form (DD214) Member 4, if applicable
12. Provide a copy of your marriage license.
13. Provide a current copy of your credit report.
14. Provide a copy of your High School Diploma or GED.
15. An oral interview will be scheduled after a review of your criminal history.
16. Pass a polygraph exam.
17. Pass a random drug screen.
